Dear Sir,

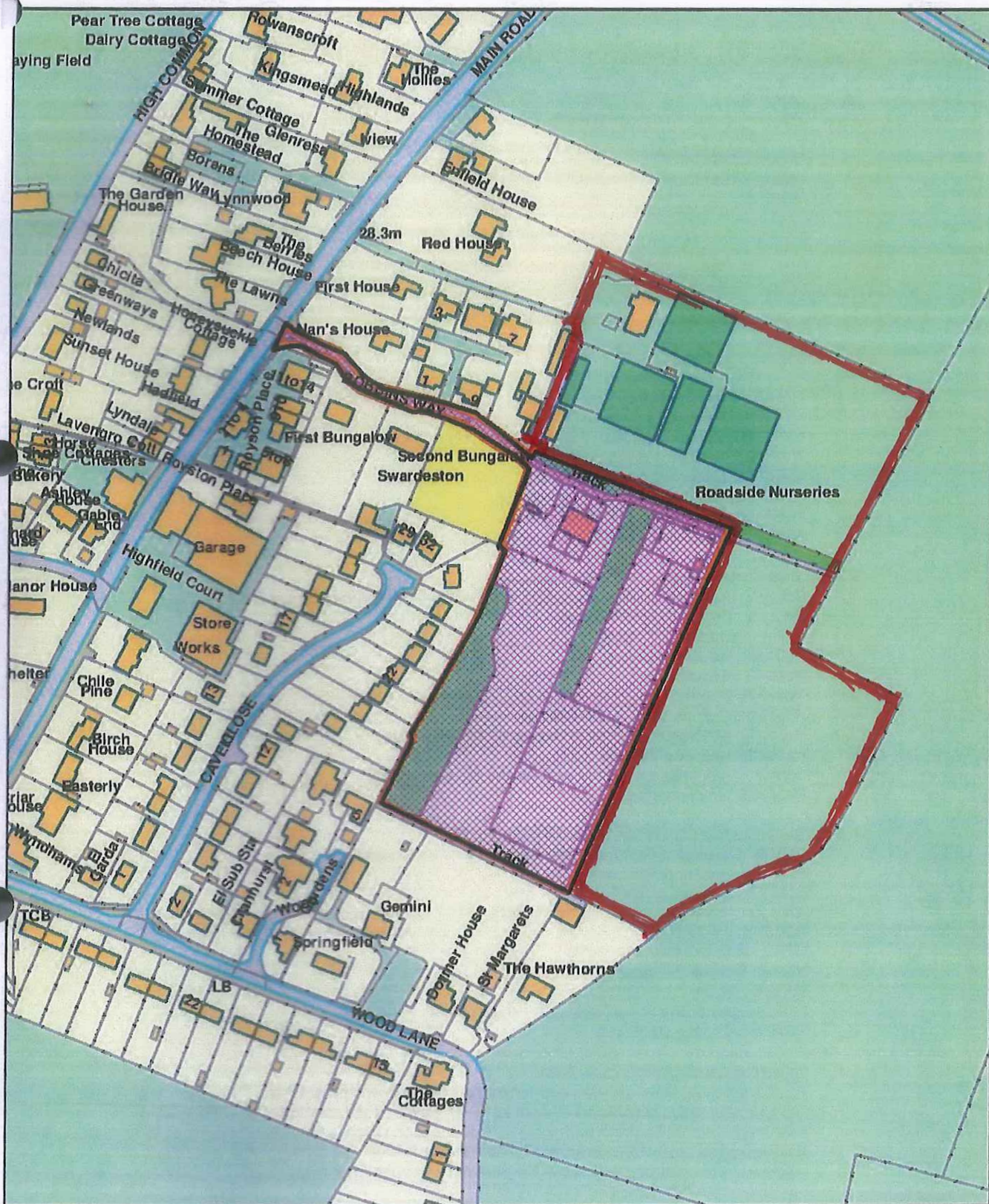
In response to your call for sites. Part or all of Roadside Nurseries will be available for you to consider.
