The proposed site would be appropriate to the size of the local village and look to develop between 5-25 residential dwellings. There would be a variety of houses, including an element of smaller dwellings aimed at being starter homes or allowing the existing elderly residents to down-size. A footpath along long lane may be required to give access for pedestrians to Norwich Road and in to the village.

The development would incorporate sustainable drainage systems avoiding any increase in rainwater run-off on to the highway. The design of the housing would reflect the vernacular design of the parish and allow adequate space between individual plots.

5d. Please describe any benefits to the Local Area that the development of the site could provide.

The development would potentially incur a CIL charge which would provide funding to the local area for improvements in infrastructure, contributions to local business and schools. The additional housing would benefit local business including two public houses, a post office, wine merchants and a garage.

If the site was allocated for development, the landowner would be open to negotiations for the possibility of providing an area for additional allotments or an area for another which is a main theme within the Strumpshaw Neighbourhood Plan.

extended further along this highway to the West. There is a public footpath that crosses the site from North West to South East. (Strumpshaw FP5)

There are no physical constraints that could affect the development proposed.

Ground conditions on the site are stable, and we are not aware any contamination issues that would affect the development proposed.

The site does not lie within an identified flood zone and we are not aware of any historic flooding incidents on the site.

We are not aware of any legal issues that would affect the development proposed.

There is the Strumpshaw Fen Conservation Area approximately 1km from the site.

There is the Strumpshaw Fen Conservation Area approximately 1km from the site.
