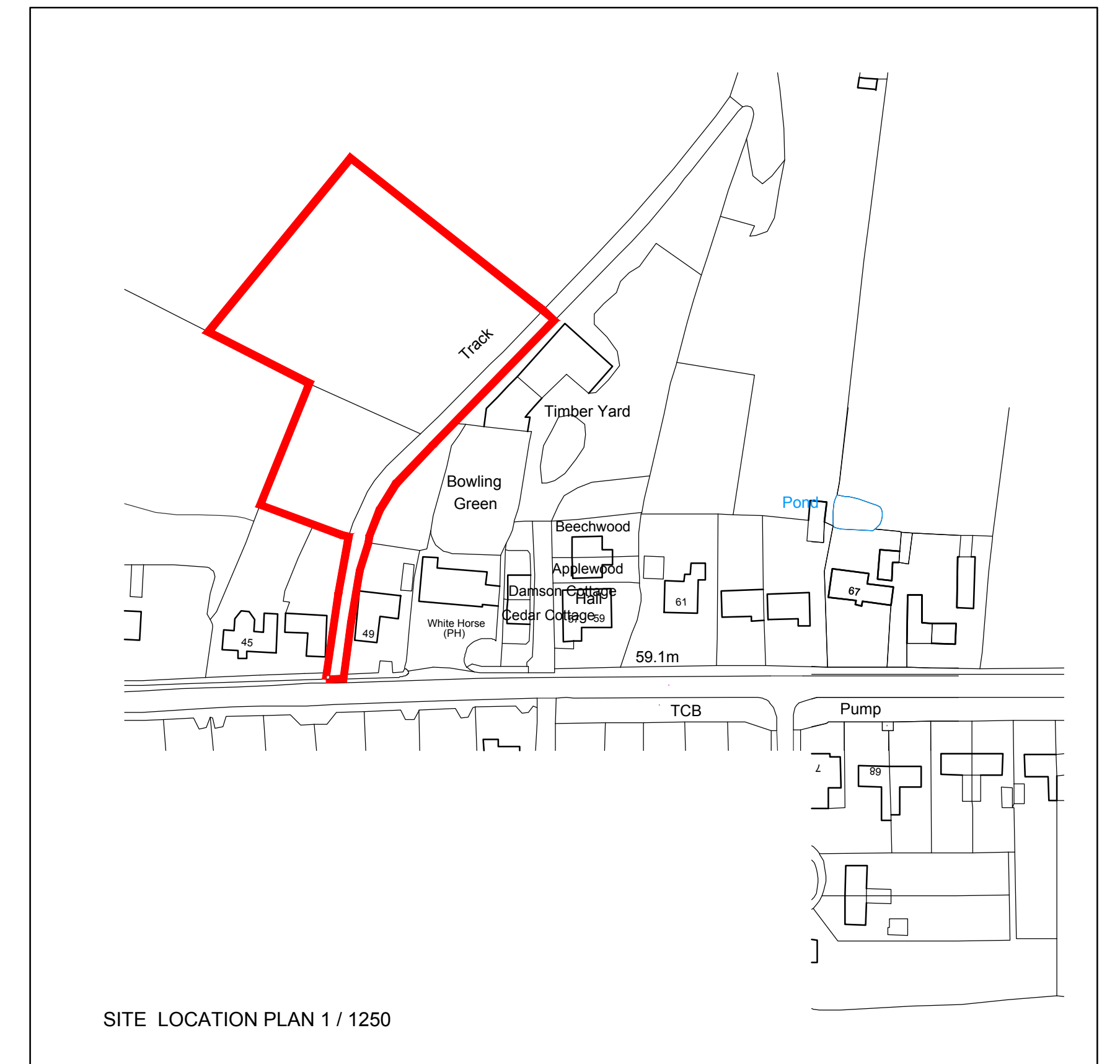
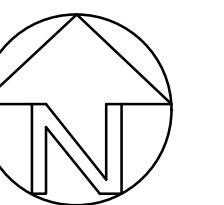


SITE PLAN 1 / 500
