At this stage, proposed housing numbers are indicative, and we would look to work with the Local Planning Authority and the Local Parish Council to identify suitable housing numbers and beneficial community facility provisions in relation to Broome in it's wider context.

The site offers an opportunity to create an attractive street frontage development, where the individual units would benefit from considerable gardens. It is located within a vicinity of existing local businesses and community facilities and is situated on a public highway which benefits from existing public transport services. Our client would be open to the principle of holding discussions with the Local Planning Authority and Local Parish Council to discuss the identification of a specified area of the potential allocation for community use.

The entirety of the site benefits from road frontage and excellent visibility onto the Old Yarmouth Road. Creating individual accesses from houses to the existing public highway would consequently be easily achievable.

The site benefits from a level topography.

The ground conditions at the site are stable, and therefore suitable for residential development. We have undertaken desktop investigations in relation to ground contamination and note that there does not appear to be any contamination issues.

We have inspected the Environment Agency flood maps, and note that the site is in an area that has a chance of flooding of less than 1 in 1,000.

There are no third party rights over the site.

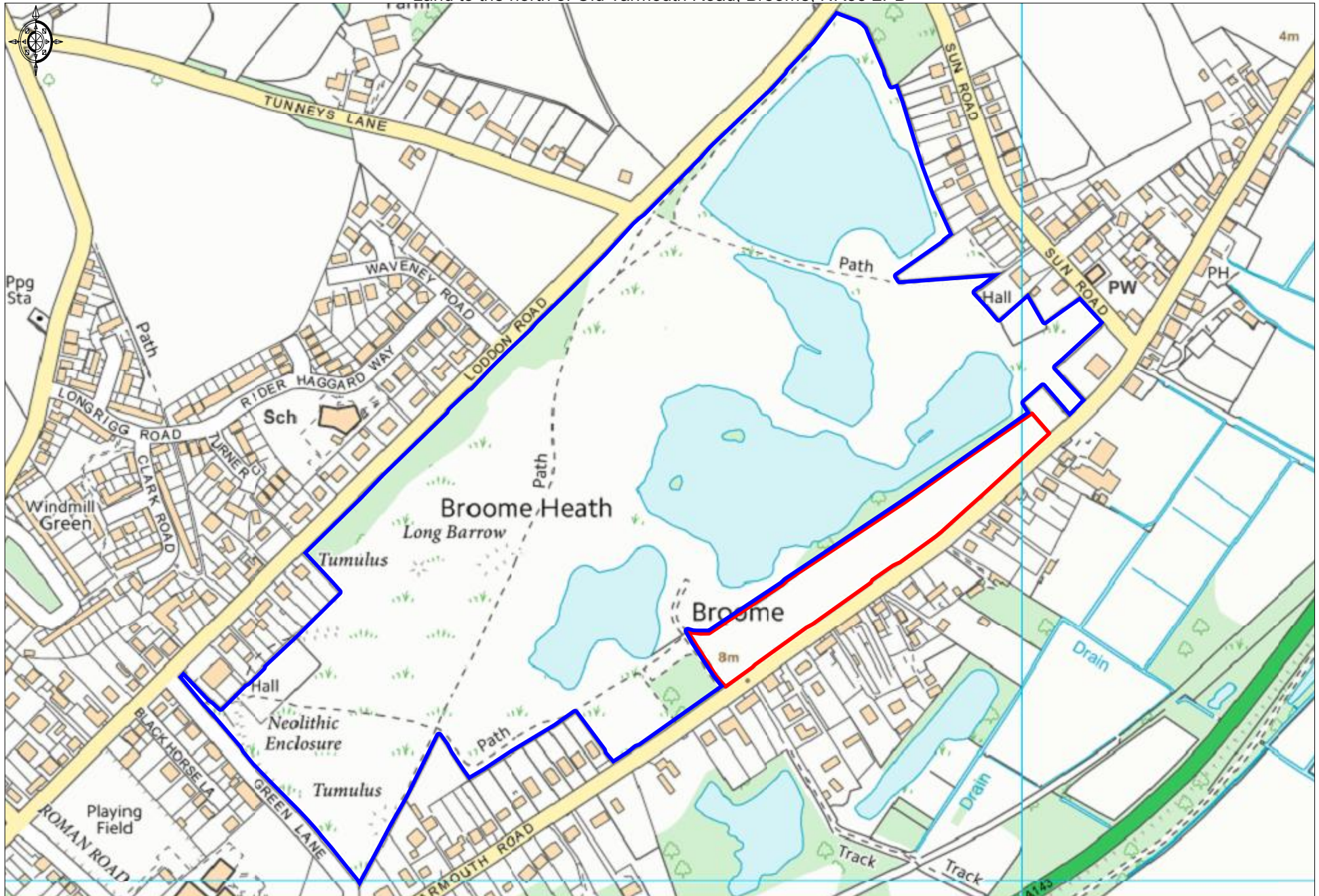
