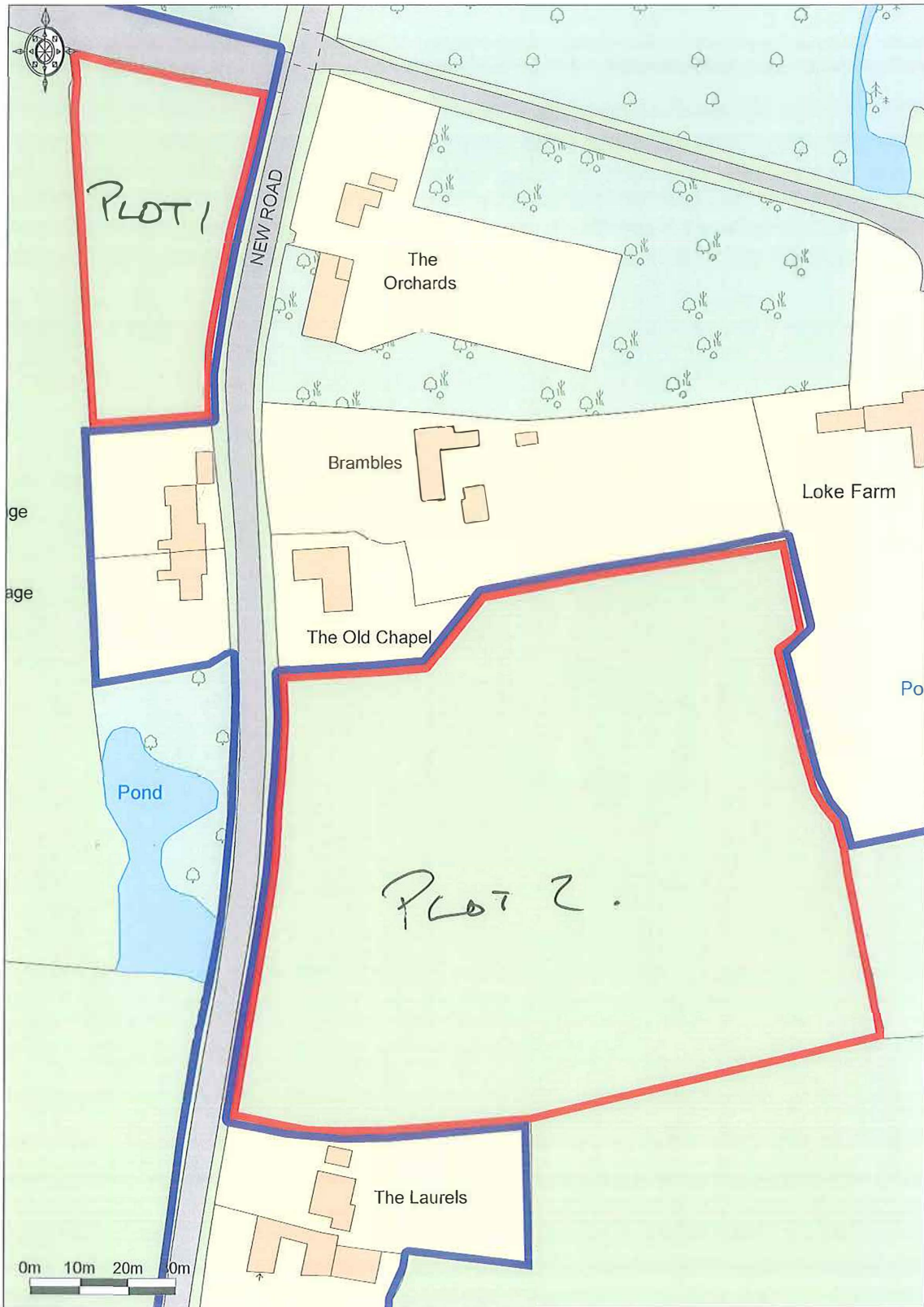

SITE PLAN OF LAND AT NEW ROAD, FUNDENHALL



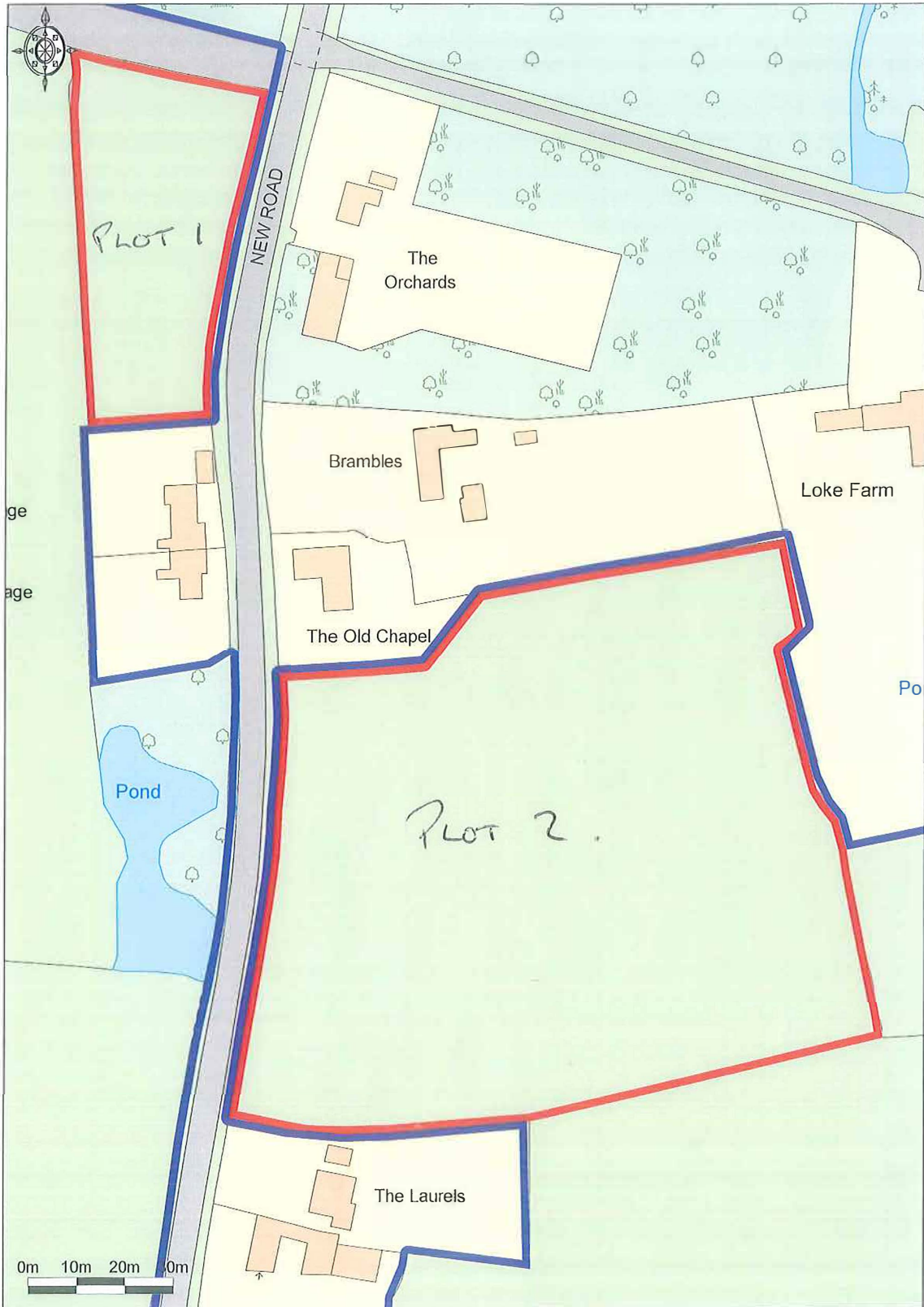
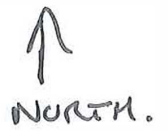
