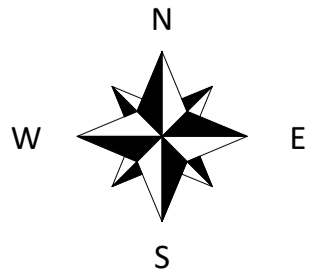


Proposed Headquarters Development for Ben Burgess on Land West of Ipswich Road (A140), Swainsthorpe, Norwich.

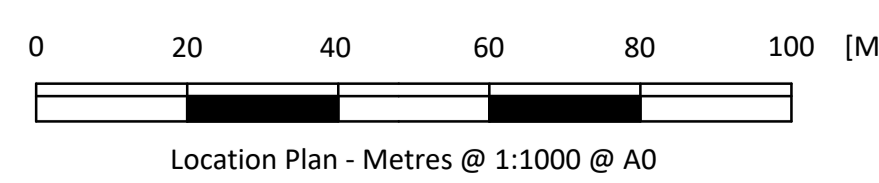
